Presidents Report

I've decided it's time to take a break and focus on other things in my life that have fallen by the wayside over the last three years in the seat.

Over the last three years I've worked to support growth in the sport, attempting to keep event entry costs to a minimum, whilst putting on more events that both give our members what they want in the calendar, as well as providing an avenue to entry level racing for newcomers.

Looking back I think a lot of what we achieved was working well – however continually operating as a "one man band" has lead to me being burnt out and unfortunately has drained a lot of my passion for the sport. Running the club requires effort from everyone – with the right people in the mix, and the right structure around it, the workload would be significantly reduced and quite manageable. One thing I can say is that whoever ends up taking over from me will have a much softer introduction to the process than I got!

There are a lot of challenges to our sport – participation levels are down and costs are up. There has been a persistent feeling of a lack of support and long term strategy for the sport from the SCB and Motorcycling Australia. It has been disheartening to see talented young riders brough up through the ranks and thrust on to an international stage with no financial support from the government or any of the sporting bodies in the country – not least MA. My intent is to take a step back for a bit, enjoy motorcycling for myself again, and then hopefully return to the mix to work on the things that I think will help to get the sport back on track and thriving again into the future.

Please ensure that you *actually* support your committee, there are a lot of good people that want to help but it doesn't take much to make a volunteer feel like their time and effort is not being appreciated, and without them there is no-one to co-ordinate or run the events that you all enjoy being apart of.

It's not goodbye, it's goodbye for now!
